Swartz & Kennedy's Response to the COVID-19

On March 17, 2020, Monterey County issued the Shelter in Place Order. On that same day, the Monterey Courts suspended all non-essential functions through April 3, 2020. This means that a small minority of cases related to In-Custody matters will continue to be heard. Otherwise, the Courts are closed to the public. This same closing has happened throughout all state courts this week.

Swartz and Kennedy considered everything we could do to help protect our clients, staff, and our Central Coast community and continue to provide the full spectrum of legal services to our clients.
